If the animal becomes critically ill, CPC will notify owner at once and a qualified veterinarian will be designated. If owner does not inform CPC immediately regarding the measures to be taken, or if the state of the animal's health demands immediate action, CPC reserves the right to contact a qualified veterinarian, administer medication and/or provide other prudent care using good judgment.

Owner of said animal will pay any and all expenses related to the treatment provided, being reasonable in cost. In the event that the animal dies, CPC will make every possible effort to contact the owner without delay. If owner does not inform CPC immediately, regarding measures to be taken, CPC reserves the right to have a qualified veterinarian provide appropriate post-mortem care and the dog's body will be preserved (cooled) at a local veterinarian's facility for Owner's identification and disposal.

If any modifications for boarding, training, medication, or veterinary assistance are not paid in full by owner within 14 days after they are due, or if said animal is not called for by owner, within 14 days after designated time for return of said animal, said animal will be sold publicly, privately or otherwise for the best available price. Notice in writing of such proposed sale will be mailed via certified mail to owner of said animal at the above address before date of proposed sale; no other notice shall be given. Said animal may be given away or euthanized if no quick sale can be made. Any and all charges, attorney's fees, court costs, collection agency fees, above charges paid by Suzi Schaefer and Canine Psychology Center, LLC will be reimbursed/paid by owner of animal.
